Other Important Terms:

- **High-Value Goods:** Products >\$1500/100KG subject to +1 USD/KG surcharge. Insurance recommended for high-value items.
- **Remote Areas:** Surcharge applies for remote addresses (+3 USD/KG for USA, +6 USD/KG for Europe)
- **Product Names:** Maximum 5 product names per shipment. +30 USD per additional name.
- **Packaging Limits:** Single piece 12-22KG. Oversize/overweight fees apply beyond limits.
- **Customs Declaration:** Separate fee of 350 USD/ticket for individual customs declaration.
- **Prohibited Items:** Mobile phones, laptops, liquids, powders, pure batteries, counterfeit goods, anti-dumping products. Strict fines for misdeclaration.
- **FDA/CPC Certification:** Required for relevant products (skin contact items, toys, etc.)

Compensation Policy:
